SUBJECT: Approve a letter of support for AB 2043 (Rivas)

REQUEST(S):

That the Board of Supervisors:

Approve a letter of support for AB 2043 (Rivas) in regards to occupational safety and health for agricultural employers and employees within the Covid-19 response.

SUMMARY:

Agricultural workers have been classified as essential workers due to the critical role they play in our society. Existing law promotes the improvement of working conditions and opportunities of wage earners; assures safe and healthful working conditions through the enforcement of effective safety and health standards, conditions, and education and training; establishes the Division of Occupational Safety and Health (known as Cal/OSHA) to propose, administer, and enforce occupational safety and health standards; and prohibits an employee from being laid off or discharged for refusing to perform work in violation of prescribed safety standards, where the violation would create a real and apparent hazard to employees.

AB 2043 (Rivas) directs the Division of Occupational Safety and Health to enforce its own COVID-19 guidance already issued by Cal/OSHA, conduct a robust culturally competent outreach campaign, via public service announcements, workplace signs, and other communications methods, to educate employers and employees related to workplace and home health and safety, and compile and report, via its website, statistics and summary information relating to investigations involving agricultural workplaces.

For Tulare County, these measures will significantly add value to the culturally competent outreach our Public Health Branch and Agricultural Commissioner/Sealer has conducted during this pandemic and ensure that our agricultural workforce is educated on health and safety best practices and receive the education and resources it needs to remain safe in the workplace.

Dear Chairman Hill:

The Tulare County Board of Supervisors is proud to support AB 2043 (Rivas) as it will protect California's agricultural employees and keep the food supply chain safe, healthy, functioning. The Tulare County Board of Supervisors recognizes the importance of our agricultural workers and the service they, and their employers, provide by keeping our food supply safe and accessible.

AB 2043 directs Cal/OSHA to disseminate culturally competent information consistent with the guidance documents and enforce the health and safety best practices as specified in the guidance documents for agricultural employers and employees. AB 2043 also funds a culturally competent and targeted outreach campaign to raise awareness around COVID-19 workplace health and safety guidance. Additionally, many workers are unaware they are entitled to paid sick leave and workers' compensation should they become infected with COVID-19; the outreach campaign will educate them on these COVID-19-related employment benefits.

Part of protecting our vital agricultural workforce means providing employees with the resources they need to address the risk of COVID-19 infection, and that includes providing them with Cal/OSHA contact information. Lastly, Cal/OSHA will be required to compile and report statistics on investigations related to agricultural workplaces.

California's agricultural employees comprise a vulnerable population -- a workforce performing intense physical labor daily. They are often medically underserved, with decreased access to healthcare, and the state must ensure that agricultural employees are able to take appropriate safety precautions in the workplace to protect themselves against infection from COVID-19. Agricultural employees are an essential and indispensable part of our workforce. It is imperative that the legislature therefore act swiftly to ensure enforcement of the Cal/OSHA issued health and safety guidance, as well as educate workers about risks in the workplace and the steps they can take to protect themselves.

These workers are putting their health and safety on the line to ensure our access to nutritious food. We have to ensure that they are able to do their very necessary work in the safest conditions possible.

For these reasons, the Tulare County Board of Supervisors supports AB 2043 (Rivas). We respectfully ask for your AYE vote in the Senate Committee on Labor, Public Employment & Retirement.
