**SUBJECT:** Approve an agreement with Kings View Corporation

**REQUEST(S):**

That the Board of Supervisors:

1. Approve an agreement with Kings View Corporation for the provision of mental health services for the South County Mobile Services program, in an amount not to exceed \$850,000 retroactive from July 1, 2020, through June 30, 2021. This agreement is retroactive due to delays in obtaining signatures from the vendor. It was impracticable for the Board to take action prior to July 1, 2020 due to the time needed to process, prepare, and submit the agenda item.
2. Find that the Board had the authority to enter into the proposed agreement as of July 1, 2020 and that it is in the County's best interest to enter into the agreement on that date.
3. Authorize the Chair of the Board to sign one (1) copy of the agreement.

**SUMMARY:**

The Tulare County Health & Human Services Agency (HHS), Mental Health Branch, collaborates with Kings View Corporation to provide mental health services through the South County Mobile Services program under the Mental Health Services Act (MHSA) Community Services and Supports (CSS) component. The South County Mobile Services program provides integrated mental health services for all age groups with severe and persistent mental illness or serious emotional disturbance with emphasis on serving those traditionally unserved and underserved in the rural communities of South Tulare County. The Mobile Services strategy is intended to decrease barriers in accessing mental health services seen in rural communities. In

addition to participating in community outreach and engagement opportunities, it is estimated that 150 unduplicated consumers will benefit from this agreement.

Tulare County Mental Health Branch released a Request for Proposal (RFP) in May 2013 for the South County Mobile Services. Through the proposal process, Kings View Corporation was the only organization to submit an application. The RFP Review Team recommended they be awarded the contract. Kings View Corporation has been providing quality services to the rural communities of Tulare County since being awarded the initial contract in 2006.

As part of the agreement, Kings View Corporation will utilize a wheelchair accessible van to provide services to remote areas of the County through outreach activities, community events, and for consumer transport to appointments, activities, and groups that will assist in their wellness recovery plan.

This agreement does not deviate from the standard County boilerplate.

**FISCAL IMPACT/FINANCING:**

The budgeted costs associated with this agreement will be included in the HHSA 3331 budget, line 7052 medical providers, for Fiscal Year 2020-2021 in an amount not to exceed \$850,000. The average cost per consumer is \$4,595. The estimated amount is subject to change based on actual utilization. This agreement is paid through State Medi-Cal reimbursement and MHSA revenues. There is no additional net cost to the County General Fund.

**LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:**

The County's five-year plan includes the Quality of Life initiative to promote and encourage the provision of quality supportive services for individuals in Tulare County. Tulare County consumers of all age groups will benefit from the provision of mental health services by the South County Mobile Services program.
