SUBJECT: Approve an agreement with Kings View Corporation

REQUEST(S):

That the Board of Supervisors:

- Approve an agreement with Kings View Corporation for the provision of opioid treatment services, in an amount not to exceed of \$1,445,000, retroactive to July 1, 2020 through June 30, 2021. This agreement is retroactive due to delays in negotiation of the terms in the agreement. It was impracticable for the Board to take action prior to July 1, 2020 due to the time needed to process, prepare, and submit the agenda item.
- 2. Find the Board has the authority to enter into the agreement as of July 1, 2020 and that it was in the County's best interest to enter into the agreement on that date.
- 3. Authorize the Chair of the Board to sign one (1) copy of the agreement.

SUMMARY:

Kings View Corporation provides Drug Medi-Cal (DMC) Opioid Treatment Program (OTP)/ Narcotic Treatment Program (NTP) services to DMC eligible consumers. This program is operated under the California State Department of Health Care Services Substance Use Disorder program regulations, as outlined in Title 9 of the Administrative Code. Consumers enrolled in this program also receive physician follow-up services and referrals to/from other agencies for rehabilitation. DMC eligible consumers from anywhere in Tulare County may be treated at this facility. The target population is opioid dependent individuals age eighteen (18) and older. In addition, Kings View Corporation provides methadone detox for eligible consumers funded

through 2011 Realignment Funds. It is estimated that two hundred (200) unduplicated consumers will be served through this agreement.

This agreement did not include a Request for Proposal process because review for Kings View Corporation is one of three contractors that provide OTP/NTP services to Tulare County consumers and the County has agreements with all three.

The following term deviates substantively from standard County boilerplate: There is a 7-year record retention period.

FISCAL IMPACT/FINANCING:

The budgeted costs associated with this agreement will be included in the HHSA 6068 budget, line 7052 medical professionals in an amount not to exceed \$1,445,000 for Fiscal Year 2020-2021. The estimated annual cost per consumer is \$4,816. The estimated cost may vary based on actual utilization. The funding is derived from Drug Medi-Cal reimbursement and 2011 Realignment funds. There is no additional net cost to the County General Fund.

LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:

The County's five-year strategic plan includes the Quality of Life Initiative that encourages innovative provision of quality supportive services for at-risk adults, youth and children in state and federally mandated programs. This agreement increases the ability to fulfill that obligation through OTP/NTP services to Drug Medi-Cal eligible consumers.
