SUBJECT: Approve an agreement with JDT Consultants, Inc.

REQUEST(S):

That the Board of Supervisors:

1. Approve an agreement with JDT Consultants, Inc. to provide Therapeutic Behavioral Services in an amount not to exceed \$500,000 from the date of full execution to June 30, 2021; and
2. Authorize the Chairman of the Board of Supervisors to sign three (3) copies of the Agreement.

SUMMARY:

The Tulare County Probation Department is seeking to establish a partnership with JDT Consultants, Inc. to provide Therapeutic Behavioral Services (TBS) to juvenile probationers. JDT Consultants, Inc. is the only TBS contractor who provides specialty mental health services in Tulare County.

TBS is an Early and Periodic Screening, Diagnosis and Treatment (EPSDT) supplemental specialty mental health service utilized as a short-term intensive one-on-one therapeutic treatment modality between a mental health coach and a juvenile probationer.

JDT Consultants, Inc. will serve referred juvenile probationers and their respective parents/caregivers (during parental sessions) at any location determined by the Probation Department.

SUBJECT: Approve an agreement with JDT Consultants, Inc.

DATE: September 1, 2020

The agreement does not contain any substantive deviations from the County standard contract boilerplate.

FISCAL IMPACT/FINANCING:

The cost of the program is covered entirely with JJCPA-YOBG funds. The agreement is not to exceed \$500,000 and is included in the Tulare County Probation Department's Fiscal Year 2020/21 requested budget. There is no net County cost to the General Fund.

LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:

The County's five-year strategic business plan includes the Safety and Security initiative that provides for the safety and security of the public. Approval of this agreement increases the ability to fulfill that obligation by providing juvenile probationers with short-term intensive one-on-one therapeutic treatment services designed to improve the quality of lives and reduce recidivism.
