SUBJECT: Ratify and confirm emergency orders and evacuations related to the Sequoia Complex Fire

REQUEST(S):
That the Board of Supervisors:
Ratify and confirm all emergency evacuation orders, and any orders rescinding evacuation orders, issued by the Director of Emergency Services, or successor, during the period of September 4, 2020 to September 15, 2020, related to the Sequoia Complex Fire Local Emergency, proclaimed on August 28, 2020.

SUMMARY:
The Sequoia Lightning Complex Fire on the Sequoia National Forest (generally referred to as the "SQF Complex") started on August 22, 2020. This incident encompasses the lightning-caused Castle Fire and Shotgun Fire. As of the time of Agenda Item submission, the fire was burning in the Golden Trout Wilderness and on both the Sequoia and Inyo National Forests.

Initial Evacuation Warnings were issued in the days following the fire's ignition; as the fire grew, a Local Emergency was proclaimed, and Evacuation Orders were issued for Ponderosa, Cedar Slope, Pyle's Camp, and points between by the Director of Emergency Services on August 28, 2020. The Board of Supervisors ratified the proclamation of Local Emergency on September 1, 2020, pursuant to California Government Code §8630(b).

Since that time, additional Evacuation Orders pursuant to Tulare County Ordinance Code Part 1, Chapter 15, Section 1030(f)(1), which must be confirmed at earliest practicable time by the Board of Supervisors. At the time of Agenda Item submission,

additional Evacuation Orders have been issued for the communities of Alpine Village, Camp Nelson, Coy Flat, Mountain Aire, Pierpoint Springs, Sequoia Crest, and points between. Additional Evacuation Orders, and/or orders rescinding some or all Evacuation Orders, may be issued between the time of Agenda Item submission and the Board of Supervisors meeting. All orders related to the Sequoia Complex Fire are posted on the Tulare County website immediately upon issuance and given widespread publicity.

FISCAL IMPACT/FINANCING:

There is no cost to issue emergency orders. Response costs for the incident will be addressed once known, and reimbursement sought from State and Federal funding sources wherever possible.

LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:

The County's five-year strategic plan includes the Safety and Security initiative, with a directive to plan and provide coordinated emergency preparedness, response, recovery and mitigation capabilities for both natural and man-made disasters. The issuance of evacuation orders supports a coordinated response to ensuring life safety during disasters.


