SUBJECT: Approve an agreement with the United States Department of Justice

REQUEST(S):

That the Board of Supervisors:

1. Approve an agreement with the United States Department of Justice to participate in the Federal Equitable Sharing program and to allow continued access to Equitable Sharing funds in the amount of \$6,033.56, retroactive to July 1, 2020 through June 30, 2021. This agreement is retroactive due to the United State Department of Justice's procedures in collecting information at the end of the preceding fiscal year. It was impracticable for the Board to take action prior to July 1, 2020 due to the time needed to process, prepare and submit the agenda item;
2. Find that the Board had the authority to enter into the proposed agreement as of July 1, 2020 and that it was in the County's best interest to enter into the agreement on that date;
3. Authorize the Chairman to sign the agreement; and
4. Authorize the Chief Probation Officer to sign the agreement.

SUMMARY:

The United States Department of Justice (USDOJ) Asset Forfeiture Program helps to remove the tools of crime from criminal organizations, deprive wrongdoers of the proceeds of the crimes, recover property that may be used to compensate victims,

and deter crime.

On March 10, 2009, the Board authorized the Probation Department to enter into an agreement with the DOJ for the distribution, maintenance, and use of seized and forfeited drug assets. Continued participation in the program necessitates an annual update of the Probation Department's Equitable Sharing Agreement and Certification (ESAC).

The ESAC allows the Probation Department to participate in the Federal Equitable Sharing Program to receive forfeited proceeds. Any received proceeds are used to purchase law-enforcement items such as safety equipment, firearms, weapons, and electronic surveillance equipment. The Probation Department's beginning Equitable Sharing Fund balance for Fiscal Year 2019-20 was \$5,885.03 and \$148.53 in interest was received to increase the balance to \$6,033.56. No equitable sharing funds were spent in FY 2019-20.

The Department would like to note that the following terms deviate substantively from the County's standard boilerplate: 1) Although the County is required to sign the agreement, it will be submitted electronically on the DOJ's template without signatures, as required by the DOJ's submission process; and 2) Submission of the agreement electronically constitutes acceptance of the agreement's terms.

FISCAL IMPACT/FINANCING:

Any revenue received from the asset forfeiture program augments the Probation Department's operating budget, thereby relieving General Fund costs. There is no net County cost to the General Fund.

LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:

The County's five-year strategic business plan includes a Safety and Security Initiative and an Organizational Performance Initiative. The Federal Equitable Sharing Program supports the Safety and Security Initiative by addressing contributors to crime, depriving criminals of the profits and proceeds of their illegal activities, and removing the instrumentalities of crime to weaken criminal enterprises. It also supports the Organizational Performance Initiative by seeking revenue from all available resources and utilizing funding to purchase safety equipment items that otherwise may have come from the general fund.
