REQUEST(S):

That the Board of Supervisors:

- 1. Approve an amendment to Agreement No. 29133 with Dominion Voting Systems, Inc. for the purchase of nineteen (19) Oki Data 712 Ballot Printers including laptops, consumables and warranty fees in an amount not to exceed \$160,000.
- 2. Approve the necessary budget adjustment per the attached AUD 308 (4/5ths vote required).
- 3. Authorize the Chairman to sign four copies of the Agreement.

SUMMARY:

On May 7, 2019, your Board approved an agreement with Dominion Voting Systems, Inc. for the purchase of the Democracy Suite 5.2 Voting System.

The Registrar of Voters would like to purchase nineteen (19) Mobile Ballot on Demand Printers in order to have one (1) printer at each of our polling locations for the November 3, 2020 General Election. The Oki Data 712 Mobile Ballot Printers will enable polling sites to print precinct specific paper ballots on demand.

With the ongoing concerns regarding the spread of COVID-19, it is important that voters not be disenfranchised and have the opportunity to vote in-person for the

November 3, 2020 General Election. Therefore, per the guidelines of SB 463, Tulare County will be providing nineteen (19) polling locations throughout the County beginning on Saturday, October 31, 2020 through Monday, November 2, 2020 from 8:00 a.m. to 5:00 p.m. and on Election Day Tuesday, November 3, 2020 from 7:00 a.m. to 8:00 p.m. Allowing voting opportunities three (3) days prior to Election Day will help prevent overcrowding while maintaining physical distancing to protect the health and safety of our voters.

The Registrar of Voters office has been allocated \$580,765 in COVID-19 funding from the State that requires no County match. The funding can be used to conduct the November 3, 2020 election in the face of the COVID-19 pandemic, which include costs related to meeting in-person voting requirements. The funds are to be used for costs that are in addition to normal election costs and do not supplant funds already allocated under State or local budget authority, as part of the normal conduct of elections.

FISCAL IMPACT/FINANCING:

Tulare County was notified by the Secretary of State on July 27, 2020 that we have been allocated \$580,765 in COVID-19 funding, and use of this funding does not require a County match. The attached AUD 308 is required to move appropriations to purchase the Capital Assets. There will be no additional net County cost to the General Fund.

LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:

The County's Five-year Strategic Plan includes the Organization Performance Initiative to provide state-of-the-art technology and infrastructure to support better service delivery. Approving the request to purchase the Ballot on Demand Printers helps fulfill this initiative by ensuring that we are improving the functionality, system security and efficiency of conducting elections.
