REQUEST(S):

That the Board of Supervisors:

1. Approve a Proclamation declaring September 22, 2020 as "National Voter Registration Day".

SUMMARY:

National Voter Registration Day is a formally recognized voter outreach initiative, which aims at registering eligible citizens so they can be empowered to cast a ballot on Election Day.

This year, National Voter Registration Day occurs on September 22, 2020. The Registrar of Voters encourages Tulare County's grassroots organizations, businesses, schools, and other civically minded groups to promote citizens to register and exercise their right to vote within their communities.
