**<u>SUBJECT</u>**: Approve the Capital Asset purchase of two vehicles for the Sheriff's Civil Unit

#### REQUEST(S):

That the Board of Supervisors:

- Approve the capital asset purchase of two vehicles to support the day-to-day operations of the Tulare County Sheriff's Office Civil Unit, in an amount not to exceed \$90,000; and
- 2. Authorize the necessary budget adjustments per the attached AUD 308 (4/5ths vote required).

#### SUMMARY:

The Tulare County Sheriff's Office is requesting Board approval to purchase two new 2020 Ford Explorers, to be used by the Sheriff's Civil Unit (CU). The CU is staffed with two full time deputies and one full time sergeant. The two vehicles will be housed and assigned for primary use by the CU in Visalia. The vehicles will be used by Sheriff's staff to serve subpoena's and other CU legal documents throughout the County, deliver critical or time sensitive Sheriff's documents to the Courts or other locations as needed, and other duties as assigned.

In 2013 two vehicles were purchased and outfitted for the two assigned CU deputies. This new request is to replace both of the vehicles as both have reached the end of their life cycle as each had well over 150,000 miles. Both vehicles were recently removed from the CU due to their mileage and the cost effectiveness of the vehicles continued maintenance costs. Due to the critical nature of the CU and their ongoing responsibilities, the CU is borrowing vehicles from other Sheriff's

units when available, until replacement vehicles are obtained.

#### FISCAL IMPACT/FINANCING:

The combined cost of the two vehicles will not exceed \$90,000. There will be no additional net County cost for the purchase of the aforementioned assets as the \$90,000 will come from the Sheriff's Civil Trust Fund 502. The vehicle quote is \$41,054 per vehicle, combined total for two vehicles is \$82,108, with a contingency of \$7,892 to allow for any unforeseen costs.

To purchase the two vehicles, the attached AUD 308 is requesting to increase the following expenditure line 001-240-2145-8342 and the following revenue line 001-240-2145-9294 by \$90,000.

### LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:

The County's five-year strategic plan includes the Organizational Performance Initiative to provide for the continuous improvement in organizational effectiveness. The purchase of the two vehicles will allow our staff work more efficiently without having to delay services or look for alternative transportation.
