REQUEST(S):

That the Board of Supervisors:

- 1. Accept the work for the construction of the 2019 Road Repair and Accountability Act Project 1, in six locations throughout Tulare County, as complete by A Teichert & Son, Inc. doing business as Teichert Construction of Roseville, California: and
- 2. Authorize the Chair of the Board of Supervisors to sign the Notice of Completion; and
- 3. Direct the Clerk of the Board to have the Notice of Completion recorded with the County Clerk-Recorder.

SUMMARY:

This Notice of Completion is for the construction of the 2019 Road Repair and Accountability Act (RRAA) Project 1. This project was completed on time and below the allowable budget. The work was performed by A Teichert & Son, Inc. dba Teichert Construction, under Tulare County Agreement No. 29287.

This project was approved by your Board on May 21, 2019 (Resolution No. 2019-0396). The lowest responsible bid was submitted by A Teichert & Son, Inc. dba Teichert Construction. On July 23, 2019, your Board awarded and approved a contract (Resolution No. 2019-0645) to A Teichert & Son, Inc. dba Teichert Construction in the amount of \$4,894,267.

SUBJECT: Notice of Completion for Construction of 2019 Road Repair and

Accountability Act Project 1

DATE: September 29, 2020

This project consisted of a combination of isolated pavement repairs followed by the installation of new asphalt surfacing, as well as full depth pulverization of existing asphalt material followed by the application of new asphalt surfacing. Work included the addition of imported aggregate materials for the roadway shoulders and the installation of new traffic striping and pavement markings.

Provided below is a summary of the roadway which received treatment as part of this project:

- Location 1 Road 152 from Avenue 256 to State Route 137 (Tulare)
- Location 2 Road 144 from State Route 201 to Avenue 416 (Orosi)
- Location 3 Road 122 from Avenue 272 to Avenue 271, Avenue 271 from Road 122 to Road 128, and Road 128 from Avenue 271 to Avenue 272 (Visalia)
- Location 4 Avenue 264 from Road 100 to Road 108 (Visalia)
- Location 5 Road 108 from Avenue 317 (Pratt) to Avenue 328 (Visalia)
- Location 6 Road 224 from Fir to Avenue 250 (Lindsay)

There were three (3) Contract Change Orders (CCO) written for this project with a net total of \$61,409.90 to credit the County. The first CCO was written in the amount of \$55,179.10 to credit the County as set forth in the "Payment Adjustment for Price Index Fluctuations" clause of the Special Provisions. The second CCO was in the amount of \$7,914.17 to credit the County for asphalt material placement outside of project specified relative compaction and to allow contract items to exceed the 125% threshold without the need to provide an adjustment to the contract item unit price. The third, and final, CCO was written in the amount \$1,683.37 to compensate the Contractor for the installation of an asphalt concrete drive approach on Avenue 272.

This project has been completed in accordance with the plans and specifications and is now ready for acceptance by the Board.

FISCAL IMPACT/FINANCING:

There is No Net County cost to the General Fund.

An allowance of 5.26% of the contract bid amount, or \$257,213, was authorized for contingencies at the time of award setting the total approved contract amount at \$5,151,480.

The final cost to complete this project was \$4,549,964.66 which is 7.03% below the bid amount and is 11.68% below the authorized contract amount plus contingencies.

This project was funded by County Road Funds.


