SUBJECT: Approve an Agreement with City of Dinuba

REQUEST(S):
That the Board of Supervisors:

1. Approve an Agreement with the City of Dinuba to provide radio and communication services effective upon execution by both parties through June 30, 2025.
2. Authorize the Chair to sign the Agreement.

SUMMARY:
Tulare County Information & Communications Technology Department's (TCiCT) radio shop exists mainly to provide services to county departments. The radio shop can also perform services for other government agencies, municipalities, special districts, or other quasi-governmental organizations. Services performed include a wide selection of radio communication services such as installation, repairs and maintenance, and direct sales of communication related products.

As part of TCiCT's strategic plan initiative to improve business processes, TCiCT is pursuing clearly specified agreements with outside agencies for those services already being performed on a regular basis. The intent of the agreement is to memorialize standards of services performed, provide a detailed warranty of services completed, and mitigate risk for both parties.

Approval of this agreement will assist TCiCT in not only meeting a strategic goal,

but also strengthening inter-agency relationships through improved and mutually agreed upon terms and conditions.

FISCAL IMPACT/FINANCING:


The proposed agreement includes the performance of various installation and repair services. Revenue will be recorded to accounting line 074-074-7400-5537. There is no Net County Cost to the General Fund as the services are fully recovered through the radio billing process.

In Fiscal Year 2020/21 it is estimated that \$128,849 in services will be performed to outside agencies. Services are performed on an ad hoc basis and are charged to the outside agency in accordance with the scope of services included as Exhibit A to the agreement. Outside agencies requesting services include, but are not limited to the cities of Dinuba, Farmersville, Woodlake, and Visalia.

LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:

The County's five-year strategic plan includes the Organizational Performance Initiative to continuously improve organizational effectiveness. The agreement to perform radio and communication services helps fulfill this initiative by setting forth the terms and conditions to provide better service delivery.
