**SUBJECT:** Approve a Capital Asset Purchase

**REQUEST(S):**  
That the Board of Supervisors:  
Approve a Capital Asset purchase for a fully equipped K-9 vehicle in the amount of \$39,624.00.

**SUMMARY:**  
The adopted budget approved for the Probation Department for fiscal year 2013/2014 included a Capital Asset purchase for a replacement vehicle and K-9 safety equipment for the Drug-Detection K-9 Team. The vehicle was ordered in fiscal year 2013/2014 however, was unable to be delivered prior to the end of fiscal year 2013/2014. Therefore, the Department is requesting authority to purchase the vehicle in fiscal year 2014/2015.

**FISCAL IMPACT/FINANCING:**  
The purchase of the vehicle has been included in the 2014/2015 proposed budget for the Probation Department. There will be no net county cost.
