**SUBJECT:** Extend the Arts Consortium’s designation as the official arts council of Tulare County through September 30, 2015.

**REQUEST(S):**  
That the Board of Supervisors:  
Presentation to approve the extension of the Arts Consortium’s designation as the official arts council of Tulare County through September 2015.

**SUMMARY:**  
The California Arts Council operates the State-Local Partnership Development Program. This is a three year program designed to build the capacity of local arts organizations. For an organization to receive these funds, that organization must be designated by the County Board of Supervisors as the official Arts Council of their county.

On October 5, 2010 the Board of Supervisors designated the Arts Consortium as the official arts council in Tulare County through April 30, 2011. The designation was extended to September 30, 2011 and again through September 30, 2014. On July 31, 2014, the board president of the Arts Consortium once again requested an extension of this designation through September 30, 2015. The designation’s timeline will coincide with the timing of future grant programs through the California Arts Council.

Staff is requesting the Board approve the extension of the Arts Consortium’s designation through September 30, 2015.
