- **REQUEST:** That your Board:
  - 1. Approve the upgrade of Advantage Financial system from CGI/AMS from release 2.2 to release 3.5 or greater with CGI/AMS and approve the contract amendment.
  - 2. Approve the purchase of additional third party software to run AFIN 3.5 or greater.
  - 3. Approve the service enhancement request with ACS.
  - 4. Approve the payment of back maintenance in order to receive the upgrade software free.
  - 5. Authorize the Chairman of the Board to sign the amendment to the original agreement with CGI/AMS and the service enhancement request (SER) agreement with ACS.

# SUMMARY & JUSTIFICATION:

In 1987 the County purchased AMS (American Management Systems) software titled LGFS (Local Government Financial System) release 7.0 for processing the County's financial data. Through the years the system has been upgraded and improved through release 14.0 of LGFS and renamed AFIN (Advantage Financial) through release 2.2. These have all been mainframe computer software packages which are in the old 1970's style computer "terminal" format.

In 2001 AMS released AFIN 3.0 and is due to release AFIN 3.6 soon. The new software upgrade is web based and a complete rewrite of the software using today's technology. Due to the initial high cost of the new software and the County's limited financial resources, the County made the strategic move to wait for better economic times to upgrade. In 2001 the County discontinued to pay software maintenance support since AMS would not provide any updates to the outdated software. Recently, AMS became CGI/AMS (Conseillers en gestion et informatique/American Management Systems and subsequently offered the County its latest software upgrade at no cost if the County were to renew and pay maintenance support retroactive to the date it was discontinued (\$218,000) in 2001.

Due to the complexity of the upgrade we will need to have consulting services from CGI/AMS as well as ACS (Affiliated Computer Services). There will also be additional equipment and software the county will need to purchase in order to run the system.

#### FINANCING:

The current capital projects budget includes funds to purchase the following: \$622,740 in new hardware and software to hold the Advantage software and data; up to \$330,000 in labor costs from ACS including a statement of work; up to \$836,000 in labor costs from CGI/AMS for installation work; up to \$125,850 in CGI/AMS travel expenses; back maintenance of \$218,000 on AFIN release 2.2 in order to receive the AFIN 3.5 software upgrade; and current maintenance due April 1, 2006 of \$192,000. Total maximum cost is \$2,324,590 for the first year, with a savings of at least \$1,173,000. The \$2,324,590 is made up of County departments contributing \$1,107,771 and \$1,216,819 out of the General Fund.

### ALTERNATIVES:

Remain with AFIN release 2.2 and within a few years it will be unable to run on the computer systems available by computer vendors due to vendors not willing to support it. If the current hardware were to break parts may not be available.

If the SER between ACS and CGI/AMS does not go into effect, the county can proceed with the county in charge of the project.

#### **INVOLVEMENT OF OTHER DEPARTMENTS OR AGENCIES:**

All departments and agencies will require training by county staff on the new software. Agencies will be billed for part of the cost of the upgrade.
