SUBJECT: Purchase of replacement computer switches

REQUEST:

- 1. That the Board of Supervisors authorize and direct the Tulare County Purchasing Department to take the necessary actions needed to purchase the state approved computer switches to replace the computer switches currently in use by the Tulare County Department of Child Support Services.
- 2. That the Board of Supervisors recognizes these computer switches as assets as defined by the County of Tulare.
- 3. That the Board of Supervisors approves a budget change to the 2005-06 budget to allow the purchase of the computer switches during the current fiscal year.

SUMMARY: It is the desire of the Tulare County Department of Child Support Services to replace the computer switches. The efforts involved both at the local and state level to meet the Federal requirements and thereby avoid the Federal Penalties has generated a need to make improvements in our technical systems. Last year, using funding from the state, the computer wiring at the Department of Child Support Services was upgraded. The switches are the second phase of this project. Due to budgetary limitations with the state and a timing issue, it was anticipated that the purchase of these assets would not be possible until the 2006/07 fiscal year. Recently, however, the state has reconsidered and is making it possible for us to purchase the hardware this year. The installation of this hardware will maximize the current configuration's potential. This will allow staff to access and input data at a faster rate providing more efficient service to our customers.
