SUBJECT: Amendment to Agreement #21628 with George Plumlee, d.b.a. Plumlee's Guest Home, a licensed augmented board and care facility.

REQUEST(S): That the Board of Supervisors:

1. Approve the amendment to Agreement #21628 with George Plumlee, d.b.a. Plumlee's Guest Home, a licensed augmented board and care facility.
2. Authorize the Board Chair to sign (3) copies of the agreement.

SUMMARY: Board and care facilities provide basic living and care services to the mentally disabled residents of Tulare County. These services can include, but are not limited to: supportive supervision, rehabilitative services including living skills, and modification of difficult behaviors. Augmented board and care homes add an additional component of specialized mental health services for those clients that have a limited ability in self-sufficiency due to chronic mental disorders. For FY 05/06 approximately fifteen (15) clients per month used this facility. We anticipate for FY 06/07 thirty (30) clients per month utilizing this facility, allowing Tulare County clients to stay closer to home, and lowering our daily expense for care.

The purpose of this amendment is to extend the term of Agreement #21628 through June 30, 2007.

FINANCING: The maximum reimbursement for Agreement #21628 for FY 2006/2007 is \$575,000 and will be included in the proposed FY 2006/2007 budget under budget line 001-142-3311-2150.

ALTERNATIVES: Place clients in a more restrictive, higher cost institution for the mentally disabled.

INVOLVEMENT OF OTHER DEPARTMENTS/AGENCIES: This agreement has been approved as to form by County Counsel and no changes have been made since this approval.
