Whereas, LESSOR and COUNTY entered into an Agreement to Lease office and storage space at 8040 Doe Avenue in the City of Visalia on June 23, 1992, which has been designated as Tulare County Agreement No. 16693 as heretofore amended, and;

Whereas, the parties desire to amend said Agreement to allow for COUNTY to prepay rent and janitorial services for a period of one year.

ACCORDINGLY IT IS AGREED:

1. Paragraph 5.1 of Tulare County Agreement No. 16693 is hereby amended to read as follows:

Prepayment of Rent: COUNTY may prepay the rent attributable to the Department of Child Support Services specified in Paragraph 5 for the time period of July 1, 2006 through June 30, 2007 or to an earlier date. The prepayments are itemized on Exhibit "K" attached hereto and incorporated by this reference with CPI adjustments estimated at 4%. Any overpayment shall be corrected with the first monthly payment due following the prepayment period. Rent for the Health & Human Services Agency warehouse shall continue to be paid monthly. In the event this Lease is terminated for any reason by either party, all unused rents paid in advance will be promptly reimbursed by LESSOR to COUNTY.

- 2. Paragraph 9.1 of Tulare County Agreement No. 16693 is hereby amended to read as follows:
 Prepayment of Janitorial Services: COUNTY may prepay the janitorial services attributable to the Department of Child Support Services specified in Paragraph 9 for the time period of July 1, 2006 through June 30, 2007 or to an earlier date. The prepayments are itemized on Exhibit "G" attached hereto and incorporated by this reference. Any overpayment or underpayment shall be corrected with the first monthly payment due following the prepayment period. In the event this Lease is terminated for any reason by either party, or if COUNTY elects to provide its own janitorial services, the unused janitorial services paid in advance will be promptly reimbursed by LESSOR to COUNTY.
- 3. Paragraph 26.1 of Tulare County Agreement No. 16693 is hereby amended to read as follows:

 Memorandum of Lease: LESSOR and COUNTY will sign a Memorandum of Lease in the form set forth in Exhibit "L", and cause their signatures to the Memorandum to be acknowledged before a Notary Public, and either party may thereafter record the Memorandum, and give the other party notice of such recording. Upon the expiration or earlier termination of the term, either party upon request will execute a document for recordation to terminate such memorandum.
- 4. All other terms and conditions of said Agreement No. 16693, as amended, shall remain in full force and effect.
