**SUBJECT:** Approval of Amendment to Agreement #21701 with Tulare County Superintendent of Schools for the "Great Expectations", Early Head Start Prenatal Program for Families.

**REQUEST(S):** That the Board of Supervisors:

- 1. Approves the amendment to Agreement #21701 with Tulare County Superintendent of Schools for the "Great Expectations": Early Head Start Prenatal Program for Families through September 30, 2006.
  - 2. Authorizes the Board to sign three (3) copies of the amendment.

**SUMMARY:** Under Agreement #21701, Tulare County Superintendent of Schools (TCSOS) purchases case management and education services from Health & Human Services Agency (HHSA) for participants in their "Great Expectations": Early Head Start Prenatal Program. Services provided by HHSA are needs and risk assessments for nutrition and prenatal care, prenatal and healthy child development education, and other related services. Agreement #21701 is set to expire on September 30, 2006.

The purpose of this amendment to set the compensation rates and maximum compensation amount for October 1, 2005 through September 30, 2006. The compensation to HHSA for this time period is not to exceed \$71,000. In FY 2005/2006 forty-six (46) expectant and postpartum parents were involved in this program so far.
