#### **Summary:**

With the departure of the former Senior Administrative Assistant to the Board of Supervisors the Board in concert with the County Administrative Office and the Human Resources department has explored a variety of alternatives with a view toward reducing costs of staffing and restructuring the delivery of services to constituents.

Essentially the Board has eliminated two positions whose combined annual salary approached \$125,000. In lieu thereof the newly created Board Representative I/II classification will result in a cost savings of not less than 23% annually.

In addition the former Senior Administrative Assistant to the Board has accepted the position of County Media Officer/Analyst in the County Administrative Office. The compensation for this new position matches the existing allocation of Administrative Analyst resulting in no increased cost to the County.

Financing: First year savings for the Board of Supervisors' budget is estimated at \$49,000

diminishing in future years as merit pay increases are awarded.

Alternatives: None.
