SUBJECT:

Delinquent Terra Bella Sewer Maintenance District service charges.

REQUEST(S):

Set a Public Hearing for August 8, 2006, at 9:30 a.m. in the Board Chambers, Administration Building, 2800 West Burrel, Visalia, California, for placing delinquent Terra Bella Sewer Maintenance District service fee charges on the 2006/07 Tax Rolls and approve the Notice of Public Hearing.

SUMMARY:

According to the Terra Bella Sewer Maintenance District Ordinance a Public Hearing is required for the purpose of placing delinquent Terra Bella Sewer Maintenance District service fee charges on the 2006/07 Tax Rolls.

The exhibits to be attached to the Notice of Public Hearing will be submitted to the Clerk of the Board after Wednesday, July 12, 2006 and no later than Friday, July 14, 2006. June 30, 2006 was the last day a service fee could be paid. The delinquent service fee charge list requires several business days to prepare.

FINANCING:

The only costs to the County are those associated with noticing and conducting the Public Hearing. These costs are included in the proposed budget.

ALTERNATIVE:

1. File a civil action for the collection of any amounts due and unpaid for each delinquent account.
2. Do not pursue the collection of delinquent charges and forfeit these revenues.

INVOLVEMENT OF OTHER DEPARTMENTS OR AGENCIES:

None required for the purpose of holding the Public Hearing.


