Summary: Alternative Services, Inc. is the contracted agency providing services for the Residential Substance Abuse Treatment (R.S.A.T) program. This program has previously been funded through a grant sponsored from the Office of Emergency Services. Currently grant funding is not available for this ensuing year. This program has proven to be very beneficial to our inmates and it is our desire to continue funding it through the Inmate Welfare Fund.

The RSAT program is designed for male inmates with drug addiction problems and who will be incarcerated for a minimum of 6 months. The targeted population is housed at the Men's Correctional Facility. A total of 64 beds has been designated for this program. Alternative Services, Inc. provides addiction counselors who address needs specific to recovery, parenting, anger management, and behavioral change.

Financing: Expenditures for the fiscal year 2006-2007, will not surpass \$120,000. The general fund will be reimbursed from the Inmate Welfare Trust Fund.

Alternatives: Direct staff to take other action.
