SUBJECT: Approval of amendment to Agreement #21707 with Turning Point of Central California, Inc. for FY2006-2007.

REQUEST(S): That the Board of Supervisors:

1. Approves the amendment to Agreement #21707 with Turning Point of Central California, Inc. to provide mental health services to Tulare County adolescents and children for FY 2006/2007.

2. Authorizes the Board Chair to sign three (3) copies of the amendment.

SUMMARY: Under Agreement #21707, Turning Point of Central California in Visalia provides mental health, rehabilitative, case management and crisis intervention services to Tulare County children and adolescents. Turning Point also provides Therapeutic Behavioral Services for short-term interventions to children meeting the criteria for these services. Turning Point of Central California provides these services under the administrative oversight of Tulare County. Agreement #21707 will expire on June 30, 2006. The purpose of this amendment is to extend the term of Agreement #21707 through June 30, 2007. Approximately 1100 clients were served by this provider in FY 2005/2006. This is a retroactive amendment to July 1, 2006. The amended agreement was not ready to be presented to the Board until today, due to the time needed to process, prepare, have the signed amendment returned by the Contractor, and then prepare the agenda item for submission.

FINANCING: The funds for this agreement are included in the FY 2006/2007 proposed budget and are paid through realignment and Medi-Cal revenues with no net county cost.
