SUMMARY: Tulare County has worked in cooperation for many years with University of California Cooperative Extension. University of Cooperative Extension was established by Congress with the Smith-Lever Act of 1914 and is authorized under the provisions of the State of California Education Code, Section 32330. The joint effort between the University of California, the United States Department of Agriculture and Tulare County began in 1918. This voluntary partnership was created to provide a better standard of living for County residents by identifying, developing and delivering research and education programs in the areas of agriculture, 4-H youth development, family and consumer science and natural resources. Major activities include direct consultation with clientele by phone, office visits, and farm/institutional visits; educational events such as seminars, training sessions, grower meetings, grower/industry field days; and targeted research projects to solve local problems. The Department also produces and distributes a variety of printed and web based educational and informational materials.

This Memorandum of Understanding continues the partnership with Tulare County and University of Cooperative Extension. At the request of the University this Memorandum of Understanding updates the prior agreement and aligns with University protocols.

It is requested that your Board approve the Memorandum of Understanding between University of Cooperative Extension and County of Tulare; and authorize the Chairman to sign the agreement.

FINANCING: Funding for the University of California Cooperative Extension is included in the 2006/2007 Fiscal Year budget.
