SUBJECT: Amendment to Agreement #22930 with Family Services of Tulare County Inc.

REQUEST(S): That the Board of Supervisors:

1. Approve the Amendment to Agreement #22930 with Family Services of Tulare County Inc. for Family Reunification and Family Preservation services for clients of Child Welfare Services through June 30, 2007.

2. Authorize the Chairman of the Board of Supervisors to sign the Amendment to Agreement #22930 with Family Services of Tulare County, Inc.

SUMMARY:

Tulare County Child Welfare Services (CWS) under Promoting Safe and Stable Families (PSSF) currently contracts with Family Services of Tulare County, Inc. to provide home based Parent Education and Family Reunification Services in the amount of \$140,000 under the Promoting Safe & Stable Families Program. This contract amendment would increase the amount of the agreement by \$20,000 for a total contract amount of \$160,000. The amount of families served would increase from 80 families and 110 adults to 160 families and 220 adults who would receive services from this contract. The amended contract would add Family Maintenance and Voluntary Family Maintenance CWS referrals.

Retroactive Agreement: This is a retroactive agreement to October 31, 2006. The amended agreement was not ready to be presented to the Board until today, due to the time needed to process, prepare, have the signed amendment returned by the Contractor, and then prepare the agenda item for submission. Therefore, although the County had the authority and intended to enter into the agreement, the amendment paperwork had to be inadvertently delayed for a short period of time.

Board Strategic Plan Initiative Addressed: Quality of Life.

FINANCING: This is included in the FY 2006/2007 Budget. There is no net county cost.

INVOLVEMENT OF OTHER DEPARTMENTS/AGENCIES: This agreement was approved as to form by County Counsel and no changes have been made to the agreement since this approval.
