**SUBJECT:** Agreement between Tulare County Health and Human Services Agency (HHSA) and the California State University Fresno Foundation for the Central California Regional Obesity Prevention Project (CCROPP) funds.

**REQUEST(S):** That the Board of Supervisors:

1. Approve the agreement between Tulare County Health and Human Services Agency and the California State University, Fresno Foundation retroactively from July 1, 2006 through October 30, 2008.

  - 3. Authorize the Chairman of the Board to sign three (3) copies of the agreement.
  - 4. Approve the attached AUD308 budget adjustment form (requires 4/5ths vote)

## **SUMMARY:**

Tulare County and the California State University Fresno Foundation share a concern about the risks to individual community health and well-being resulting from malnutrition and the lack of adequate physical activity that can result in obesity.

The Central California Regional Obesity Prevention Project (CCROPP) goal is to create changes in our environments that support healthy eating and active living. The Tulare County Health and Human Services Agency, Public Health Division will develop a County Obesity Prevention Council and work to reduce obesity through advocacy and policy change, as well as strengthen current Health Department capacity within the community. Additionally, Tulare County will support the efforts of the Regional Obesity Prevention Program, by participating in region-wide assessment, goals and activities. Project year is from November 1st to October 31st, for all three years. *Retroactive Agreement:* this is a retroactive agreement to July 1, 2006. The agreement was not ready to be presented to the Board until today, due to the time needed to process, prepare, have the signed agreement returned by the Contractor, and then prepare the agenda item for submission.

Board Strategic Plan Initiative Addressed: Quality of Life

**FINANCING**: The three-year agreement is in the amount of \$224,440. Funds for years one through three will be \$55,138, 82,975 and \$86,327 respectably. Revenue from this grant is not included in the approved County budget for fiscal Year 2006-2007 and form AUD 308 has been completed and attached for approval. There are no matching requirements and there is no net county cost associated with this program.

**INVOLVEMENT OF OTHER DEPARTMENTS/AGENCIES:** This agreement has been approved as to form by County Counsel and no changes have been made since this approval.
