Approval of Mental Health position changes to provide the support and

accountability required to facilitate the Mental Health Services Act (MHSA).

REQUEST(S):

That the Board of Supervisors:

1. Approve the attached Personnel Resolution changing the Job Classification to better meet the needs of the Mental Health Services Act (MHSA) requirements.

SUMMARY: In May of 2006, the Board approved the acceptance of Mental Health Services Act (MHSA) funding from the State Department of Mental Health for the establishment of new programs. The new programs and corresponding new revenue was defined in the MHSA Community Services and Supports 3-Year Expenditure Plan that was approved by the State Department of Mental Health on April 28, 2006.

After completion of six months of operation, it has been determined that it is necessary to adjust the staffing as originally budgeted and submitted as part of the Community Services and Supports 3-Year Expenditure Plan for Fiscal Year 2006-2007. In order to provide fiscal oversight for both new contract service providers, and those that are established, we are requesting the following changes:

Add:

1.0 FTE Accountant II

Delete:

1.0 FTE Staff Services Analyst III

By authorizing this change, Tulare County Health and Human Services (HHSA) will better provide technical assistance, training, accountability, and audit oversight needed to facilitate the MHSA program in a positive and professional manner. An Accountant will be able to provide the training and technical support on proper claims procedures, identifying cost related activities, acceptable billing procedures and a standardized format for detail and subsequent updates.
