REQUEST(S):

That the Board of Supervisors:

- 1. Hold a Public Hearing at 9:30 a.m. on May 8, 2007, to receive comments regarding the close-out of Community Development Block Grant No. 03-EDBG-909.
- 2. Authorize the Chairman of the Board, or authorized designee, to sign the final Grantee Performance Report.
- 3. Authorize the County Administrative Officer, or authorized designee, to sign the final close-out certification documents.
- 4. Authorize submittal of all signed close-out documents to the State Department of Housing and Community Development.

SUMMARY:

In June of 2004, Tulare County was awarded a \$300,000 Community Development Block Grant (CDBG) from the State Department of Housing and Community Development (HCD). The County utilized the 03-EDBG-909 grant funds to provide microenterprise technical assistance and training to 134 Tulare County low-income residents. Additionally, 10 new microenterprises have been established, and 16 jobs have been created as a direct result of this program. Training was provided by Central California Small Business Development Center (CCSBDC) and Community

Services & Employment Training (CSET).

This grant expired February 17, 2007. The close-out process includes a requirement from HCD to hold a public hearing prior to submittal of the final Grantee Performance Report and Close-Out Report at the end of the CDBG contract term. The purpose of the public hearing is to provide citizens of Tulare County the opportunity to review and comment on the County's performance in fulfilling its obligations under the terms of the grant. The CDBG-required notice of public hearing is to be published in the Visalia Times Delta on April 20, 2007, and the affidavit of publication will be provided to the clerk following receipt.

FISCAL IMPACT/FINANCING:

Grant close-out activities are eligible CDBG administration expenses. All administrative funds have been expended under this grant. Therefore, budget number 001-230-4215 will absorb the administrative cost for the remaining close-out activities. There will be no net County costs.

LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:

Economic Well-Being: This Program attracted and retained a diverse business community in all regions of the County, promoted and provided a business friendly, can-do service ethic, and expanded enterprise and redevelopment zones. Additionally, the County was able to collaborate with the Economic Development Corporation to promote this program to businesses countywide.

ALTERNATIVES:

Having accepted the CDBG grants, there is no alternative to holding the required Public Hearing. The Board has the option to direct revision to the close-out documents.

INVOLVEMENT OF OTHER DEPARTMENTS OR AGENCIES:

State Department of Housing and Community Development to review close-out documentation; Resource Management Agency Accounting to review grant balances; Community Development and Redevelopment Division to oversee close-out procedures; and CCSBDC and CSET to provide final documentation.
