Public Hearing to consider an appeal of the Planning Commission's decision to modify and approve in part Setback Variance No. PSV 07-001

REQUEST(S):

That the Board of Supervisors take the following action:

Deny the appeal submitted by Tom C. and Carolyn Moshier (Agent: Lane Engineers, Inc.) and uphold the Planning Commission's modified approval of Setback Variance No. PSV 07-001, which denied the requested variance from State Route 201, subject to the findings and conditions set forth in Planning Commission Resolution No. 8218.

SUMMARY:

Tom C. and Carolyn Moshier (Agent: Lane Engineers, Inc.) propose a single family residential subdivision of 9.58 acres into 25 lots (23 residential lots, one ponding basin lot, and a Lot A, which is designated for the private roads), in the R-A-12.5 (Rural Residential-12,500 sq. ft. minimum) Zone on property located on the northeast corner of State Hwy. 201 and Road 32, east of Kingsburg.

The tentative map proposal included a setback and zone variance to allow a sevenfoot concrete block wall to be located within the setback area of State Route 201 and Road 32 (42.5 feet from the center line of State Route 201 right of way, as SUBJECT: Public Hearing for an appeal for Setback Variance No. PSV 07-001

opposed to the required 60 feet, and 30 feet from the center line of Road 32 right of way as opposed to the required 50 feet.)

Timothy and Carol Thiel, adjacent property owners to the east, raised concerns regarding the location of the block wall along State Route 201. Concerns regarding the placement of the block wall on State Route 201 were not resolved to the satisfaction of the Planning Commission and the Setback Variance was modified to deny the setback request for State Route 201. The requested setback variance on Road 32 and the zone variance to allow the seven-foot high block wall and interior fencing were deemed appropriate for the development. (See attached Planning Commission Resolution No. 8218 for details.)

Correspondence dated April 26, 2007, was received from Lane Engineers, Inc., agent for the applicants, filing an appeal to the Planning Commission's denial of the requested set back variance on State Route 201. (See attached correspondence)
