SUMMARY:

The District Attorney's Office requests the purchase of the special equipment to be used in conjunction with the Rural Crime Prevention Program. The funds to purchase the equipment are available from a grant from the United States Department of Agriculture (USDA) and a cash match which will be made from the District Attorney's Office budget. It is requested that your Board approve the fixed asset for the purchase of the special equipment and the necessary budget adjustment.

FISCAL IMPACT/FINANCING:

There is no additional impact to the General Fund. All expenses will be paid from the USDA grant funds of \$44,250 and a match of \$14,750 from the District Attorney's budget for a total of \$59,000.

The County's five-year Strategic Business Plan and Management System include Safety and Security Initiatives to provide for the safety and security of the public. The purchase of the special equipment helps fulfill this initiative by adding equipment to be used in the investigation and prosecution of agricultural crime. This added ability will help ensure that cases will be effectively and fairly investigated and prosecuted.
