SUBJECT:

Approval of sole source purchase of 126 Fire Hose nozzles.

REQUEST(S):

That the Board of Supervisors:

- 1. Approve the sole source purchase of AKRON fire hose nozzles from LN Curtis in the amount \$66,064.
- 2. Authorize the Purchasing agent to waiver bid and make the sole source purchase.

SUMMARY:

The Fire Department has a mix of styles, types and brands of fire hose nozzles which creates safety & operational deficiencies. A substantial portion of our current nozzles are made by Akron, which is the desired department standard.

To ensure safety, uniformity, maintenance compatibility and operational consistency for all Fire Department nozzles, we request approval for a sole source purchase of additional AKRON nozzles. These can only be obtained from LN Curtis, Inc. which is the exclusive west coast distributor for AKRON products. We need to purchase 126 of these units at a total cost of \$66,064.00

FISCAL IMPACT/FINANCING:

Funds for this purchase are identified in the small tools account of the approved Fire Department operating budget for Fiscal Year 2007-2008. There is no change in Net County Cost.

LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:

This action helps provide for the safety and security of the public by providing necessary equipment to fire department emergency responders.
