REQUEST(S):

That the Board of Supervisors:

- Accept a \$194,000 grant from the California Office of Homeland Security to purchase the following equipment: (5) repeaters, (30) portable radios, (1) Medium Duty Rescue/Decon Specialized Mission Vehicle, and (1) ID Card Printer and Software System.
- 2. Authorize the Purchasing Agent to purchase the Medium Duty Rescue/Decon Vehicle from the General Services Administration price list.
- 3. Authorize the necessary budget adjustment per the attached AUD 308 (4/5ths vote required).

SUMMARY:

The California Office of Homeland Security annually awards grants for police, fire, and other first responders to prepare for threats to critical infrastructure, communication systems, public health and other disaster scenarios.

Tulare County Fire Department has been awarded \$194,000 from the Fiscal Year 2007 Homeland Security Grant (Notification letter attached). The award will fund the following purchases:

- Five (5) repeaters at a total cost of \$20,000. The purpose of this equipment is to enhance interoperable communications.
- Thirty (30) portable radios costing \$30,000. This equipment will also serve to enhance interoperable communications.
- One (1) Medium Duty Rescue/Decon Vehicle at a cost of \$140,000. This

vehicle will provide immediate response HAZMAT/decontamination needs. Ferrara, the vehicle vendor, has verified that General Services Administration pricing will apply per their Contract Number GS-305-000IN.

• One (1) ID card printer and software system for \$4,000. This system is needed to provide personnel with proper identification.

FISCAL IMPACT/FINANCING:

The Homeland Security Grant of \$194,000 will pay the full purchase price of the listed equipment. There will be no Net County Cost.
