REQUEST(S):

That the Board of Supervisors:

Approve a grant application to Pacific Gas & Electric Company for the purchase of trees and shrubbery for the Tulare County Youth Facility.

SUMMARY:

Pacific Gas & Electric Company accepts grant applications to improve energy conservation and the environment through the planting of trees and shrubbery around public facilities. The Probation Department's Youth Facility would be able to purchase environment-appropriate trees and shrubbery to improve the grounds surrounding the building at no cost to the county.

FISCAL IMPACT/FINANCING:

Pacific Gas & Electric Company would provide up to \$3,000 for the purchase of environmentally-appropriate trees and shrubbery for the Probation Youth Facility. There are no net county costs associated with the grant.
