REQUEST(S):

That the Board of Supervisors:

- 1. Approve License Agreement with the State of California, Department of Developmental Services, Porterville Developmental Center for use of suite located at 1225 South "O" Street in the City of Tulare.
- 2. Authorize the Chairman of the Board to sign the License Agreement.

SUMMARY:

State of California, Department of Developmental Services, Porterville Developmental Center has a need of a suite to perform autopsies in Tulare County and has requested the use of the Tulare County Sheriffs Department Morgue Building. The Sheriffs Department has responded to the request and is willing to provide access to the facility. The rental cost for use of the autopsy suite shall be \$100 per hour for any and all hours needed to perform each autopsy. Usage of the morgue shall be as needed, on a case by case basis, during morgue facility business hours or as mutually agreed upon by both parties. The term shall commence upon execution of the License Agreement.

FISCAL IMPACT/FINANCING:

There is an anticipated decrease in net County cost to the General Fund. Revenue to County for use of suite at \$100 per hour for any and all hours needed to perform each autopsy. Unable to determine yearly revenue as it is on a case by case basis.
