# REQUEST(S):

That the Board of Supervisors:

- 1. Approve the Memorandum of Understanding (MOU) with the Fresno County Sheriff's Department to participate in the Fresno Internet Crimes Against Children Task Force (Fresno ICAC) through January 1, 2011.
- 2. Authorize the Chairman to sign four copies of the MOU.

## **SUMMARY:**

The U.S. Department of Justice funds the Internet Crimes Against Children (ICAC) grant program. The program funds regional collaborations of law enforcement agencies to investigate, apprehend and prosecute sexual predators who use the Internet to exploit children. Locally, the Fresno ICAC program is funded through the federal ICAC grant program.

The Tulare County Sheriff's Department has operated the Tulare County Sexual Assault Felony Enforcement (SAFE) program since spring 2007 with funding from the California Emergency Management Agency. The SAFE team is composed of Sheriff's Department, the District Attorney's Office and non-profit Family Services of Tulare County. The team enforces mandated registration requirements on sexual

offenders, investigates sexual crimes, and educates the public on how to avoid being a victim of a sexual offender. The SAFE team also conducts investigations of sexual offenders that use the Internet to prey on unsuspecting youth.

The attached MOU delineates responsibilities of the Fresno ICAC Task Force, maximizes inter-agency cooperation, and formalizes relationships between members agencies. By joining Fresno ICAC, the County of Tulare will receive free training for the SAFE team. This training will significantly enhance the team's Internet investigations of sexual predators. SAFE also will benefit by sharing information on sexual offenders with other law enforcement members of Fresno ICAC. The information exchange should lead to enhanced investigative efficiency by both SAFE and Fresno ICAC task forces.

# **FISCAL IMPACT/FINANCING:**

The County of Tulare will not receive any funds as a result of joining the Fresno Internet Crimes Against Children Task Force. However, the Fresno ICAC will provide free training to the Sheriff's Department.

There will be no net County cost as a result of participating in the Fresno ICAC.

# LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:

The Tulare County Strategic Business Plan includes a Security and Safety Initiative. Participating in the Fresno ICAC program will allow the Sheriff's Department to more efficiently operate its Sexual Assault Felony Enforcement (SAFE) program, thereby lessening the danger posed to Tulare County residents by sexual offenders.
