

FIRST AMENDMENT TO AGREEMENT

Tulare County Agreement Number 23800 is amended on _____, between the **COUNTY OF TULARE**, hereinafter referred to as "COUNTY" and **ARIEH R. WHISENHUNT**, M.D. hereinafter referred to as "CONTRACTOR" with reference to the following:

A. The COUNTY and CONTRACTOR entered Agreement No. 23800 to provide competent psychiatric services for the Department of Mental Health of Tulare County Health and Human Services Agency, including services required by the participation of the Department of Mental Health for Managed Care Plans, Medi-Cal, and other patients.

B. The COUNTY and CONTRACTOR agree to amend Agreement No. 23800 to extend the termination of Agreement to June 30, 2010, and update Exhibits "A," "B," and "C."

C. This amendment shall become effective July 1, 2009.

ACCORDINGLY, IT IS AGREED:

I. Effective July 1, 2009 paragraph 1 entitled Term in the original Agreement is hereby revised to identify the new termination date of June 30, 2010.

II. Effective July 1, 2009 Exhibit "A" is substituted in its entirety with the attached Exhibit "A," which Exhibit is made a part of this Agreement by reference.

III. Effective July 1, 2009 Exhibit "B" is substituted in its entirety with the attached Exhibit "B," which Exhibit is made a part of this Agreement by reference.

IV. Effective July 1, 2009 Exhibit "C" is substituted in its entirety with the attached Exhibit "C," which Exhibit is made a part of this Agreement by reference.

V. Except as provided above, all other terms and conditions of Agreement No. 23800 shall remain in full force and effect.

SCOPE OF SERVICES

FISCAL YEAR 2009-2010

SCOPE OF SERVICES

CONTRACTOR shall provide culturally and linguistically competent psychiatric services in specific Tulare County Mental Health Clinics, or other designated sites as specified by the Tulare County Mental Health Medical Director or his/her designee.

CONTRACTOR shall complete Service Activity Log's (SAL's) for submission to Tulare County Mental Health Clinic's Clerical/SAL staff for billing and reporting processing. SAL's shall be completed and turned into clinic clerical staff no later than 48 hours of the date the service was provided. Psychiatric Evaluations and progress notes must be attached to the SAL in order for the SAL to be processed. All original copies of the client's medical records must be retained in the client's chart and shall be stored at the Tulare County Mental Health Clinic site. Training and Documentation standards must be followed according to Tulare County Mental Health Plan.

COUNTY agrees to provide malpractice insurance to CONTRACTOR.

Terms and conditions applicable to all Medical Malpractice Program members are subject to the CSAC-EIA Memorandum of Coverage. The next policy period begins as of October 1, 2007 to October 1, 2009.


