SUBJECT: Presentation Regarding the 2009 Youth@Work Summer Program

REQUEST(S):

That the Board of Supervisors:

Receive a presentation regarding the use of \$3,957,662 in youth funds awarded under the American Recovery and Reinvestment Act (ARRA) to fund the 2009 Youth@Work summer program.

SUMMARY:

The Tulare County Workforce Investment Board and its funded Service Providers (CSET, Proteus, and SEE Youth) served over 1,800 young people in the 2009 Youth@Work summer program. Program funding was to provide summer employment opportunities to low-income, at-risk youth ages 14-24.

Youth began the program with a series of "Work Readiness" workshops that provided information on the hiring process (applications, resumes, interviewing); success in the workplace (appearance, personal habits, time management, communication strategies, team work and personal responsibility); Life skills (money management, self-sufficiency, career exploration and education planning); safety, non-discrimination, and operational policies. After completing the workshops, youth were placed in their work experience assignments. Typically youth worked 150

hours at \$8.00 per hour.

FISCAL IMPACT/FINANCING:
