#### **SUMMARY:**

The United Way of Tulare County asked that Board of Supervisors pass a resolution to declare September 2009 as "Energy Efficiency Month" in Tulare County.

This resolution recognizes the advantages of energy efficiency and its many benefits. Those benefits include: saving money now and in the future; helping to protect the environment; helping to enhance the economy; and helping to promote energy security.
