SUBJECT:

Approval of agreement with BHC Sierra Vista Hospital to provide short term, inpatient psychiatric services.

REQUEST(S):

That the Board of Supervisors:

- Ratify and approve an agreement with BHC Sierra Vista Hospital in an amount not to exceed \$150,000 to provide short term, inpatient psychiatric services, retroactive to July 1, 2009 through June 30, 2010. This agreement is retroactive due to inadvertent delays in obtaining authorized signatures on the agreement. It was impracticable for the Board to take action before July 1, 2009 due to the time needed to process, prepare, and submit the agenda item;
- Find that the Board had authority to enter into the proposed agreement as of July 1, 2009 and that it was in the County's best interest to enter into the agreement on that date; and
- 3. Authorize the Chairman of the Board to sign three (3) copies of the agreement.

SUMMARY:

Tulare County Health and Human Services Agency (HHSA), Department of Mental Health proposes to contract with BHC Sierra Vista Hospital for the provision of 24-hour, short term, medically necessary acute psychiatric inpatient care, special

treatment services, and crisis stabilization to Tulare County residents as described in Title 22 of the California Code of Regulations. Tulare County's most recent agreement with BHC Sierra Vista Hospital for services was provided under Tulare County Professional Services Agreement No. 3446, which expired on June 30, 2008. Previously, BHC Sierra Vista Hospital had provided services to approximately twenty-four (24) Tulare County residents.

FISCAL IMPACT/FINANCING:

The maximum reimbursement for this Agreement is \$150,000 and is included in the Fiscal Year 2009/2010 budget. No Net County Cost.

LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:

The County's five-year strategic plan includes the Quality of Life Initiative that encourages innovative provision of quality supportive services for at-risk adults, youth and children in state and federally mandated programs. This agreement increases the ability to fulfill that obligation.

ALTERNATIVES:

The Board could choose not to approve this agreement, but that is not recommended, because this agreement enables the Tulare County HHSA, Department of Mental Health to fulfill the requirements to provide short term, inpatient psychiatric services mandated by Welfare & Institutions Code 5150.
