Renewal of the General Liability I and II insurance programs.

## REQUEST(S):

That the Board of Supervisors:

Approve Renewal of the General Liability I and II insurance programs.

#### **SUMMARY:**

The County has utilized a \$250,000 (SIR) self-insured retention for its general liability insurance program since July of 2003. The County participates in the California State Association of Counties-Excess Insurance Authority) pool and purchases optional excess coverage.

The General Liability I Program through CSAC-EIA includes coverage excess the County's \$250,000 SIR up to \$1 Mil. The County participates in the CSAC-EIA General Liability II Program and the expiring coverage with optional excess provided \$36 Mil in total limits.

The CSAC-EIA Executive Committee and Board of Directors met on June 3, 2010 and approved new terms. For renewal the General Liability I and II Programs have been aggressively marketed. The General Liability II Program offering for the County is \$9 Mil excess \$1 provided by Ironshore Indemnity Company with Torus Insurance Limited providing \$15 Mil excess limits. The total limits for the two programs at renewal will be \$24 Mil excess \$1 Mil. Additional Optional Excess Limits will be available of \$10 Mil. Optional Excess quotes are not yet available and

are expected within the next 30 days.

For renewal County Counsel fees are included up to \$200 per hour. In addition the exclusion for lead has been eliminated subject to the condition of a favorable review by the insurer, Ironshore Indemnity Company, of a member survey to assess the existing exposure.

Buckman-Mitchell Insurance Brokers were invited to quote but did not submit a renewal option for this coverage year.
