#### REQUEST(S):

That the Board of Supervisors:

- 1. Approve the Memorandum of Understanding between Tulare County Superior Court and County of Tulare for 2010/2011.
- 2. Authorize the Chairman to sign the agreement subject to County Counsel approval.

#### **SUMMARY:**

Tulare County provides a variety of services to the Tulare County Superior Court. The County will provide internal services, such as printing and copier maintenance. They will also provide motor pool and any other temporary services the Court requests and the County is willing to provide, including telecommunications, mail and courier services. The Memorandum of Understanding establishes services and reimbursement details each year. The setting of services, rates and the development of support documentation required by the State have been completed. Services will be provided by Facilities and General Services and other County departments as needed.

#### FISCAL IMPACT/FINANCING:
