- C. Pursuant to said bankruptcy court order, Agreement No. 20039 was listed as No. 118 on Second Amended Exhibit A (Pre-Petition Contracts to be Assigned to Clean Harbors, Inc. as Part of the Sale of the Chemical Services Division).
- D. WHEREAS, as authorized by said bankruptcy court order, COUNTY and CLEAN HARBORS amended the original agreement on December 2, 2003 by substituting CLEAN HARBORS as the new contractor for SAFETY-KLEEN; by amending the scope of work; and by amending certain rates charged for the services to be provided under the original agreement.
- E. The COUNTY and CONTRACTOR amended Agreement No. 20039 on October 14, 2008 to update prices contained in Exhibit "B."
- F. The COUNTY and CONTRACTOR agree and wish to amend Agreement No. 20039 to update prices contained in Exhibit "B."
 - G. This amendment shall become effective July 1, 2010.
