SUBJECT: Approval of Tulare County Health & Human Services Agency (HHS) Named Facilities or Named Persons for the Provision of California Welfare & Institutions (W&I) Code Section 5150 Evaluation Services for Mentally Disordered Persons.

REQUEST(S):
That the Board of Supervisors:

1. Approve the named facilities as facilities designated by the County and approved by the State Department of Mental Health for 72-hour treatment and evaluation;
2. Approve the named classes or persons named who may, upon probable cause, take, or cause to be taken, mentally disordered persons described in California W&I Code Section 5150 into custody and place them into a facility described in paragraph 1, for 72-hour treatment and evaluation;
3. Approve the designations under this Resolution effective through June 30, 2011. All previous designations are hereby revoked; and
4. Direct the Clerk of this Board to send certified copies of this Resolution to the Director of each Authorized Facility, the Director of Turning Point of Central California and the Director of Tulare Youth Services Bureau.

SUBJECT: Approval of Tulare County Health & Human Services Agency (HHSA) Named Facilities or Named Persons for the Provision of California Welfare & Institutions (W&I) Code Section 5150 Evaluation Services for Mentally Disordered Persons.

SUMMARY:

Tulare County Health & Human Services Agency, under California W&I Code 5150, is designated to name facilities and classes of persons to detain, evaluation, and treat certain mentally ill disordered persons from Tulare County.

- I. The following facilities will be authorized to receive persons involuntarily detained under California W&I Code Section 5150 from Tulare County:
Kaweah Delta Behavioral Health Hospital – Visalia; County of Merced, Psychiatric Health Facility (PHF) – Merced; Community Hospitals of Central California, dba: Community Behavioral Health Center – Fresno; Tuolumne General Hospital – Sonora; Aurora Vista Del Mar Hospital – Ventura; BHC – Alhambra Hospital – Rosemead; BHC – Heritage Oaks Hospital – Sacramento; BHC – Sierra Vista Hospital – Sacramento; Braswell Enterprises, Inc., dba: Sierra Vista Hospital – Highland; Alta Bates Summit Medical Center – Berkeley; Aurora Charter Oak Hospital – Covina; California Specialty Hospital – Vallejo; City of Angels Medical Center – Ingleside; College Hospital – Costa Mesa; Del Almo Hospital – Torrance; Dominican Hospital – Santa Cruz; Inland Mental Health Associates – Chino; Las Encinas Hospital – Pasadena; Loma Linda University Hospital – Redlands; Mills-Peninsula Hospital – Burlingame; Paradise Valley Hospital – National City (San Diego); Sharp Memorial Hospital – San Diego, and Sutter Memorial Hospital – Sacramento
- II. The following classes of person are designated as those who may, upon probably cause, take or cause to be taken, mentally disordered persons described in California W&I Code Section 5150 into custody and place them into the aforementioned facilities for 72-hour treatment and evaluation:
 - A. The following licensed staff at Kaweah Delta Mental Health Hospital:

This list of licensed staff may change at any time by Kaweah Delta Mental Health Hospital with the approval of the Tulare County Mental Health Director or his/her designee.

- B. The following licensed staff of the aforementioned authorized facilities with the exception of Kaweah Delta Mental Health Hospital:
Licensed Psychologists; Licensed Clinical Social Workers; Licensed Marriage and Family Therapists; Licensed Psychiatric Technicians;

- C. The following staff classifications of Health & Human Services Agency: Licensed Psychologists; Licensed Clinical Social Workers; Licensed Marriage and Family Therapists; Licensed Psychiatric Technicians; Psychiatrists/Physicians; Crisis Services Worker; Crisis Intervention Workers; Mental Health Unit Managers; and Registered Nurses
- D. The following staff classifications at Turning Point of Central California and the Tulare Youth Services Bureau: Psychiatrists; Licensed Psychologists; Licensed Clinical Social Workers; Licensed Marriage and Family Therapists, and Licensed Psychiatric Technicians

III. HHSA is required to submit this request for approval to the Board of Supervisors annually. This identifies the facilities and classes of persons your Board approves to initiate the detention, evaluation, and treatment of mentally disordered persons under California W&I Code Section 5150. No other facility or class is authorized to implement this code. A certified copy of your Board Resolution is sent to each authorized facility and the Director of Health & Human Services Agency.
