REQUEST(S):

That the Board of Supervisors:

- 1. Approve the letter of support for the \$8.4 million increase to \$11 million allocated for the County Veterans Service Offices.
- 2. Authorize the Chairman of the Board to sign three (3) copies of the letter of support.

SUMMARY:

Tulare County Veterans Office has been established since 1944 and continues to assist veterans in filing benefit claims with the U.S. Department of Veterans Affairs and the State of California.

The Tulare County Veterans Service Office is extensively involved with community outreach events in Porterville, Tulare, and Visalia. Also, the Tulare County Veterans Service Officer is a member of the Tulare County Suicide Prevention Task Force, the Veteran's Court Board, and the Veterans Opportunity Day Committee.

California has over 2 million veterans and 30,000 new veterans are discharging out of the service each year in California. County Veterans Service Offices have been helping veterans obtain their benefits, thereby bringing new monies into the State and diverting veterans from State and local programs. Governor Schwarzenegger proposed in his May Budget Revise an \$8.4 million increase in the money allocated for the County Veterans Service Offices. The Assembly Budget Subcommittee for State Administration voted unanimously in favor of this increase. We are requesting the Board's support of this increase through your approval of the Chairman of the Board signing the attached Letter of Support.

RE: Support County Veterans Service Offices State Budget Increase

Dear Legislators:

We strongly urge you to approve the \$8.4 million increase in the money allocated for the County Veterans Service Offices (CVSO's) that Governor Schwarzenegger proposed in his May Budget Revise. The Assembly Budget Subcommittee for State Administration voted in favor of this increase unanimously.

The Governor has initiated Operation Welcome Home which seeks to connect our young men and women returning home from the current conflicts with jobs, benefits, and reintegration assistance. County Veterans Service Offices need these funds to outreach to and assist our state's veterans.

The proposed \$8.4 million increase would raise the total money to be allocated for CVSO's to \$11 million. This is in accordance with SB 419 (Chaptered 2009) which raised the allocation ceiling to \$11 million. The proposed budget increase will update the funding formula that left the counties picking up 85% of the CVSO's costs.

For every dollar spent by the state on CVSO's, \$100 is brought into the state in new federal monies. Many veterans and their dependants, by virtue of their military service, are entitled to pension, disability, health care, educational, and burial benefits. For over 60 years, CVSO's have been helping veterans obtain their benefits, thereby bringing new monies into the state and diverting veterans from state and local programs. On average over \$200 million in federal funds are brought into the state's local economies annually.

Tulare County Veterans Office has been established since 1944 and continues to assist veterans in filing benefit claims with the U.S. Department of Veterans Affairs and the State of California. Last year their efforts brought about \$4.5 Million into the County economy.

The Tulare County Veterans Service Office is extensively involved with community outreach events in Porterville, Tulare, and Visalia. Also, the Tulare County Veterans Service Officer is a member of the Tulare County Suicide Prevention Task Force, the Veteran's Court Board and the Veterans Opportunity Day Committee.

California has over 2 million veterans and 30,000 new veterans are discharging out of the service each year in California. We urge you and your colleagues to support the Governor's efforts to help our veterans.
