

FOURTH AMENDMENT TO AGREEMENT

Tulare County Agreement Number 22949 is amended on _____ between the COUNTY OF TULARE, hereinafter referred to as "COUNTY," and ALPAUGH UNIFIED SCHOOL DISTRICT, hereinafter referred to as "SCHOOL DISTRICT" with reference to the following:

- A. The COUNTY and SCHOOL DISTRICT entered into Agreement No. 22949 on November 14, 2006, in order for the TULARE COUNTY SHERIFF'S DEPARTMENT to provide a Deputy Sheriff to serve as a School Resource Officer at the SCHOOL DISTRICT an average of one day a week.
- B. The parties amended the agreement on June 10, 2008, to extend the term of the agreement to no later than January 31, 2009.
- C. The parties amended the agreement on March 3, 2009, to extend the term to June 30, 2009, and to update the amount the SCHOOL DISTRICT will pay for the deputy's salary and benefits.
- D. The parties amended the agreement on September 15, 2009, to extend the term to June 30, 2010, and to update the amount the SCHOOL DISTRICT will pay for the deputy's salary and benefits.
- E. The parties wish to extend the term to June 30, 2011; and to update the amount the SCHOOL DISTRICT will pay for the deputy's salary, benefits, communications, transportation and related expenses.
- F. This amendment will become effective on July 1, 2010.

ACCORDINGLY, IT IS AGREED:

- I. Effective July 1, 2010, Paragraph 1, of Tulare County Agreement No. 22949, entitled TERM, is amended to add the following:
 - a. This fourth amendment shall become effective July 1, 2010, and shall terminate no later than June 30, 2011.
- II. Effective July 1, 2010, Exhibit "A" entitled Secure Our Schools is substituted in its entirety with the attached Exhibit "A" entitled Southern Tulare County School Resource Officer, which Exhibit is made a part of this Agreement by reference.
- III. Except as provided above, all other terms and conditions of Agreement No. 22949 and subsequent amendments shall remain in full force and effect.

THE PARTIES, having read and considered the above provisions, indicate their agreement by their authorized signatures below.
