SUMMARY:
Elections Code specifies that the Registrar of Voters shall prepare a Certified Statement of Results of the Election and submit it to the governing body. The governing body shall declare the elected or nominated person(s) to each office voted on at each election under its jurisdiction specifying the person(s) having the highest number of votes for the office as provided by law. The governing body shall also declare the results of each measure voted on at the election under its jurisdiction. Reference Elections Codes § 8140, 8141, 15372, and 15400.


