WHEREAS, the vision of the Tulare County Department of Child Support Services is that children can count on both parents for the financial, medical, and emotional support they need to be healthy and successful.

WHEREAS, the purpose and mission of the Tulare County Department of Child Support Services are to enhance the well-being of children by assuring that assistance in obtaining support, including financial and medical, is available to children through locating parents, establishing paternity, establishing support obligations, and monitoring and enforcing those obligations.

WHEREAS, more than 41,000 children benefit each year from services provided by the Tulare County Department of Child Support Services, with approximately \$38 million dollars in child support monies expected to be collected and distributed in Federal Fiscal Year ending September 30, 2010, enabling children to grow up in a healthy environment where they receive the financial, medical, and emotional support they need from both parents is among our highest priorities; and

WHEREAS, August 2010 has been selected as Child Support Awareness Month in the State of California.
