Approval of agreement with Family Services of Tulare County, Inc. for the provision of a Supervised Visitation Program.

REQUEST(S):

That the Board of Supervisors:

- 1. Ratify and approve an agreement with Family Services of Tulare County, Inc. in an amount not to exceed \$233,250 to provide an intensive supervised visitation program for foster children in Tulare County, retroactive to July 1, 2010 through June 30, 2011. This agreement is retroactive due to inadvertent delays in obtaining authorized signatures on the agreement. It was impracticable for the Board to take action before July 1, 2010 due to the time needed to process, prepare, and submit the agenda item;
- 2. Find that the Board had authority to enter into the proposed agreement as of July 1, 2010 and that it was in the County's best interest to enter into the agreement on that date; and
- 3. Authorize the Chairman of the Board to sign three (3) copies of the amendment.

SUMMARY:

Tulare County Health & Human Services Agency (HHSA), Child Welfare Services (CWS), is requesting to contract with Family Services of Tulare County, Inc. to provide an intensive supervised visitation program for foster children in Tulare

SUBJECT: Approval of agreement for the provision of a Supervised Visitation

Program with Family Services of Tulare County, Inc.

DATE: July 27, 2010

County. Through this Agreement services will be provided to an estimated 240 families.

Intensive supervised visitation during the first four months is crucial to the reunification process. Studies have consistently demonstrated that frequent interaction between parent and child increases not only the likelihood of reunification, but expedites the timeliness of reunification. It is especially important when an infant is involved as parents need multiple visitation contacts in order to bond. Supervised visitation also provides opportunities for trained staff to monitor the interaction between child and parent.

FISCAL IMPACT/FINANCING:

The maximum amount of this contract is for \$233,250 and will be included in the Fiscal Year 2010/2011 budget. No Net County Cost.

LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:

The County's five-year strategic plan includes the Quality of Life Initiative that encourages innovative provision of quality supportive services for at-risk adults, youth and children in state and federally mandated programs. This agreement increases the ability to fulfill that obligation.

ALTERNATIVES:

The Board may choose not to sign the Agreement or direct staff to take other action, but this is not recommended as it could limit the ability to provide additional supervised visitation services to families reunifying with their children. These services enable children to return to their family.
