SUBJECT:

Approval of amendment to Agreement No. 24233 with the City of Porterville.

REQUEST(S):

That the Board of Supervisors:

- Ratify and approve an amendment to Agreement No. 24233 with the City of Porterville for the Recycle-Only Household Hazardous Waste Program, retroactive to July 1, 2010 through June 30, 2011. This agreement is retroactive due to inadvertent delays in obtaining authorized signatures on the amendment. It was impracticable for the Board to take action before July 1, 2010 due to the time needed to process, prepare, and submit the agenda item;
- 2. Find that the Board had authority to enter into the proposed agreement as of July 1, 2010 and that it was in the County's best interest to enter into the agreement on that date; and
- 3. Authorize the Chairman of the Board to sign three (3) copies of the amendment.

SUMMARY:

Through Tulare County Agreement No. 24233, the County of Tulare and the City of Porterville established a Joint Powers Agreement for a Recycle-Only Household Hazardous Waste Collection Facility to divert household hazardous waste (HHW)

from the solid waste stream. The County of Tulare provides the equipment, containers and labels, expertise, and advice necessary to operate the Facility and transport or arrange for transport of recyclable household hazardous waste materials collected at the Facility.

The City of Porterville provides the appropriate site, including buildings and staff to oversee the Facility and receive, segregate, containerize, and label household hazardous waste materials from the public. The Facility is located at the City Corporation Yard at 555 N. Prospect in Porterville, California. Recycled household hazardous waste material that is accepted at the Facility are: latex paint; used oil; used oil filters; antifreeze; spent lead-acid batteries; nickel-cadmium, alkaline, carbon-zinc, or other small batteries; intact spent fluorescent lamps; and intact spent high intensity discharge (HID) lamps.

The renewal of this agreement allows for the continuation of the Porterville Recycle-Only Center. Other than the period covered by the Agreement, there have been no changes to the Agreement.

The original agreement was approved as to form by County Counsel and was approved by the Board of Supervisors on September 29, 2009. There were no deviations from the County contract protocol included in the original agenda item. The proposed amendments to the agreement do not include any deviations from the County contract protocol.

The only changes from the original agreement, as amended to date, is changing the time period of the agreement to extend the date of termination to June 30, 2011.

FISCAL IMPACT/FINANCING:

There is no funding associated with this agreement. All materials to be provided by the County will be purchased using grant funds and/or land fill permit fees. No Net County Cost.

LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:

The County's five-year strategic plan includes the Safety and Security initiative that provides for an adequate and safe water supply. Used oil, antifreeze, and other items, if improperly disposed of, can result in severe ground water contamination problems. Insuring that these materials are properly recycled is a priority in the Recycle-Only Household Hazardous Waste Program. Approval of the renewal of this Agreement helps fulfill this initiative by furthering the management of ground water.
