WHEREAS, Charles Hargis purchased Imperial Ambulance, Inc. from the Porterville Fire Department and later partnered with Myron Wilcox. Both men responded to calls with two old ambulances, a 1956 Cadillac and a 1958 Pontiac; and

WHEREAS, in 1962, the company's office manager, Orville Lofton, bought out Hargis and added a funeral coach and limousine service to the business. Together, Lofton and Wilcox responded to calls; and

WHEREAS, today, Imperial Ambulance, Inc. is owned by Wilcox, and Lofton's two daughters, Linda Robinson and Emily Thiroux. They have 13 full-time and 31 part-time employees; and

WHEREAS, Imperial Ambulance, Inc. has been a tremendous community partner by participating in such events as parades, fireworks shows, Relay for Life, the Santa Fe Elementary School car show, the Porterville Health Career Fair, the Senior Citizen Spring Ball, the Star Prom for the disabled, Porterville Celebrates Reading, and the Porterville City Fair, among others.

NOW, THEREFORE, BE IT RESOLVED that the Tulare County Board of Supervisors do hereby honor Imperial Ambulance, Inc. on its 50<sup>th</sup> anniversary and its continuing effort to employ skilled medical professionals who provide emergency and non-emergency care with the utmost compassion to Tulare County's patients.



#### HONORING RICHARD ORTEGA FOR HIS SERVICE TO THE CITY OF TULARE

**WHEREAS**, Richard Ortega was appointed to the Tulare City Council in August 2001 to fill a vacancy left by the death of Council Member Reatha Retherford; and

WHEREAS, Richard was elected to the City Council in November 2002 for a four-year term; served as Mayor from December 2004 to December 2006; and was reelected for an additional four-year term in November 2006; and

WHEREAS, as a member of the City Council, Richard represented the City of Tulare on various boards and commissions such as the California Partnership for the San Joaquin Valley, the Tulare Chamber of Commerce Board of Directors, the Tulare County Association of Governments, and the City Library Building Project Committee, to name a few; and

WHEREAS, under Richard's leadership, the City of Tulare expanded services by constructing a new library and fire station, got voters to approve a sales tax increase that has been used for public safety, including the repair of streets, and renovated Zumwalt Park; and

WHEREAS, Richard's passion has been to improve downtown Tulare and he has fostered a vision that includes mixed-use developments and other changes that would bring more people to not only shop but to live in the downtown area; and
