**REQUEST(S):**  
That the Board of Supervisors:  
Reaffirm Resolution No. 2010-1016, adopted December 21, 2010.

**SUMMARY:**  
This agenda is to reaffirm Resolution No. 2010-1016, adopted December 21, 2010, declaring the County of Tulare to be in a state of emergency due to the winter storm of 2010. Tulare County is experiencing severe property and economic loss as a result of the winter storm of 2010. Reaffirmation of this Proclamation will allow Tulare County to take all necessary actions to obtain State and Federal assistance and minimize regulatory burden to provide relief in the event accumulated economic losses are recoverable. In addition, Tulare County will have the requisite declaration in place to file a claim and that a copy of the resolution will be forwarded to all appropriate agencies.

provide coordinated emergency preparedness, response, recovery and mitigation capabilities for both natural and man-made disasters. The winter storm of 2010 has created conditions of property and economic loss within Tulare County, evidenced by flooding of homes and infrastructure, retention ponds at maximum capacity or overflowing, and substantial amounts of water being removed or redirected via pumps and sandbags.

**ALTERNATIVES:**

Not to reaffirm proclamation of a local emergency. However, this is not recommended as this may prevent Tulare County from taking the necessary actions to obtain State and Federal assistance.
